### I want to do a course at FSNLC...

#### Am I eligible for a government subsidised training place?

You are eligible for a government subsidised training place at FSNLC if you are:

- An Australian citizen
- Holder of a permanent visa **YES →**

#### Fee for service - full fees

**\$10.00** per scheduled hour (SCH)

#### For example:

A 480 SCH EAL course = **\$4800.00**  
**(Capped at \$1000.00 per term)**

**Concession** is to be applied to individuals who hold a current and valid

- a) Health Care Card Issued by the Commonwealth
- b) Pensioner Concession Card
- c) Veteran's Gold Card
- d) an alternative card or concession eligibility criterion approved by the Minister

(As per 2018 Skills First Program Guidelines about Fees 3.7)

#### Asylum Seekers

a Learn Local Organisation, it may confirm an individual's eligibility for the Asylum Seeker VET Program by using the Commonwealth Visa Entitlement Verification Online (VEVO) to confirm the individual holds a valid:

- a) Bridging Visa Class E (BVE);
- b) Safe Haven Enterprise Visa (SHEV); or
- c) Temporary Protection Visa (TPV).

#### Accredited Training - Non Concession Students

- **\$350** for each course a student enrolls in.  
**Term 4 - No Accredited enrolments \***

#### Accredited Training - Concession Students

- **\$70** per course (being 20% of the standard fee)  
(As per 2018 Skills First Program Guidelines about Fees 3.2)  
**Term 4 - No Accredited enrolments \***

#### Accredited Training - Asylum Seeker with allowable visa

- No charge

**\*Term 4 - EAL training - All students studying EAL in Term 4, will be enrolled in pre-accredited - Literacy for further learning at the appropriate EAL level.**

- **\$35**

#### Pre-accredited Training - Non Concession Students

- **\$350 - \$250 per year** for each course a student enrolls in, plus **\$100** IT/Equipment Levy

#### Pre-Accredited Training - Concession Students

- **Literacy for Further Learning \$70** (\$50 plus \$20 Learning Materials)
- **Computer classes \$70 concession** (\$50 plus \$20 IT/Equipment Levy)

#### Calendar year courses -

- EAL Frameworks
- Literacy for further learning
- Course In Initial General Education for Adults (Lifeskills Cooking)
- Certificate I In Initial General Education for Adults (Introductory) (Lifeskills Cooking)
- Language and literacy for employability

**\* (\*NB students already enrolled in an accredited course at FSNLC do not pay an additional fee for the first additional pre-accredited course)**

#### Semester courses -

- All Computer courses

#### Short course

- Pathways
- Job talk

**NOTE: Pathways, Language and Literacy for Employability, Mindworks, Job talk courses are free.**

- All students enrolling in Accredited Training will receive a Statement of Fees prior to enrolling, detailing costs, government contribution and course details (As per 2018 Skills First Program Guidelines about Fees 1 1.2)
- Once a student **completes a first semester computer course** (and they are **only** doing a computer course), they are no longer a student, because the semester course is completed. They therefore **need to pay a new enrolment fee if they want to do a new computer course** in the second semester. All Computer courses are only enrolled for **the semester only**.
- Students are eligible to enrol in and commence a maximum of 2 Government Subsidised courses in 2018, **this includes** courses with other training institutions. (2018-19 Restricted VET Funding Contract, and are limited to 2 Government courses at the same level in their lifetime. Schedule 1 - 2 2.3)
- The student fees are indicative only and subject to change.
- As per AQTF guidelines Condition 5 (Option 3) The RTO may accept payment of no more than \$1000 from each individual student prior to the commencement of the course. Following course commencement, the RTO may require payment of additional fees in advance from the student but only such that at any given time, the total amount required to be paid which is attributable to tuition or other services yet to be delivered to the student does not exceed \$1,500.
